ORDER:-

1. The Board of A.P. Sheep and Goat Development Cooperative Federation Limited in its meeting held on 12-8-2009 has approved the draft MoU and resolved the following:-

"The Public Enterprise Department in its Lr. No. 3084/PE-II/99, dated: 5.11.99 has decided to have the Managing Director & other staff from A.P. State Meat & Poultry Development Corporation Ltd. for A.P. Sheep Federation. At present, the post of Managing Director, APMDCL is of the rank of Director of Animal Husbandry.

The post of Managing Director & present staff of APMDCL are being transferred to APSDC Federation Ltd. The Director of Animal Husbandry also submitted proposals to Government for posting of Managing Director (in the rank of Director of AH) to the APSGDC Federation Ltd.

In view of the above & as per the Bye-Law No. 2(h) of the Federation, the Board has resolved to request the Government for appointment of an officer of the rank of Director of Animal Husbandry (Non-Cadre Post) as Managing Director of the AP Sheep & Goat Development Federation Limited, who is authorized to sign the MOU on behalf of APSGDCF Ltd to be entered with APMDC Ltd, for taking over of the Assets, Liabilities & Staff of APMDC Ltd. and also to fulfill all other formalities as per the provisions of the Registered Bye-Laws of the Federation."

2. The Managing Director, A.P. Meat Development Corporation Limited, Hyderabad in his letter first read above, has informed among other things that the Board has resolved to appoint the Managing Director to the A.P. Sheep and Goat Development Cooperative Federation Limited and also to authorize him to sign the MoU so that all the formalities can be completed as per the provisions of the Registered Bye-Laws of the Federation.

3. In view of the circumstances, Government after careful examination, hereby appoint Dr. D.Venkateswarlu, Additional Director (AH) presently working as Managing Director, A.P. Meat Development Corporation Limited, as Managing Director, A.P. Sheep and Goat Development Cooperative Federation, pending promotion in the cadre of Director Animal Husbandry (Non-Cadre Post). Dr. K.Chandra Sekhara Reddy, Technical Officer, is hereby kept in Full Additional Charge of the Post of M.D., A.P. Meat Development Corporation Limited until further orders.
